About the Authors

During his tenure at the World Bank, Dr. Yusuf was the team leader for the World Bank–Japan project on East Asia's Future Economy from 2000 to 2009. He was the director of the *World Development Report 1999/2000, Entering the 21st Century.* Prior to that, he was economic adviser to the senior vice president and chief economist (1997–98), lead economist for the East Africa Department (1995–97), and lead economist for the China and Mongolia Department (1989–93).

Dr. Yusuf has written extensively on development issues, with a special focus on East Asia, and has also published widely in various academic journals. He has authored or edited 23 books on industrial and urban development, innovation systems, and tertiary education. His three most recent books are *Development Economics through the Decades* (2009); *Tiger Economies under Threat* (coauthored with Kaoru Nabeshima, 2009); and *Two Dragonheads: Contrasting Development Paths for Beijing and Shanghai* (also coauthored with Kaoru Nabeshima, 2010). Dr. Yusuf currently consults with the World Bank and other organizations.

Kaoru Nabeshima holds a PhD in economics from the University of California, Davis, and received his BA in economics from Ohio Wesleyan University.
